Good afternoon we are writing with two important health and safety notices – please read the following information and note that action will be taken without further notice.

**DO NOT CLIMB ON THE SCAFFOLDING / DO NOT ALLOW CHILDREN TO CLIMB ON THE SCAFFOLDING**

We have received reports of young people accessing the scaffolding from flats. Scaffolding and work sites are extremely dangerous and not for playing on. Please supervise your children and be vigilant.

If you see any unauthorised persons on the scaffolding, please report it to the contractor's RLO on 07541 916 254.

**DO NOT THROW CIGARETTES OR MATCHES OUT OF THE WINDOW**

Despite the contractor's requests, some people are still throwing cigarettes out of windows.

This is a very dangerous thing to do as the cigarette could start a fire, burn someone or blow into someone else's window.

Contractors maintain good housekeeping as part of their health and safety regime, but flammable materials will be on the scaffolding at times, including the insulation which is being removed from the outside of the building. A lit cigarette could ignite such materials with serious consequences.
